#### OBJECTIVE

The Joint Chiropractic sought to improve its compliance program by consolidating all processes within FloQast, eliminating the need for a third-party compliance platform and enhancing overall efficiency

#### WHY FLOQAST?

- Seamless Integration: Consolidates compliance and underlying accounting processes into one platform, eliminating the need for separate tools.
- Real-Time Compliance: Provides immediate insights with continuous control monitoring through real-time dashboards, enhancing transparency and reducing manual updates.

In 2021, <u>The Joint Chiropractic</u> (NASDAQ: JYNT) sought to streamline its reporting, gain workflow visibility, and speed up the month-end Close. Since implementing FloQast, the team has dramatically <u>improved its Close process</u>, gaining workflow visibility and speeding up reporting.

When <u>Kelly Vargas</u>, <u>Vice President</u>, <u>Corporate Controller</u> caught wind of a <u>Compliance</u> solution within the <u>FloQast platform</u>, she saw a chance to bring everything into FloQast, thus providing a big win for the company's comprehensive compliance program. ### Achieving Compliance Excellence: The Joint Chiropractic's Path to Success

Challenges with the Prior Compliance Platform

- · Complexity and Lack of Intuitiveness
  - · Manual intervention riddled compliance processes
  - · Unintuitive, non-user-friendly UI
  - FloQast evidence was used by downloading and then uploading into disparate compliance solution
  - Lack of real-time view into compliance status

As The Joint Chiropractic continued to optimize its accounting processes, much of the prior compliance platform's drawbacks gave Kelly pause, but that was the best solution available to them at the time. That is, until they heard about <u>FloQast Compliance</u> Management.

"The prior compliance platform wasn't very intuitive for me, especially when it came to setting up users and their workspaces," Kelly said. "If someone left our company, I had to manually reassign the control owner one by one or contact their help desk for mass changes, which was time-consuming. The platform had multiple windows to navigate through for each task, which made it challenging to get a real-time view of our compliance status. It felt like a black box, and I struggled to keep track of where we were in the process."

While on a check-in call with FloQast's Accounting Success team, Kelly learned of the forthcoming Compliance Management solution and volunteered to test the product. # Reaping the Rewards: Efficiency and Integration with FloQast

**Efficiency and Integrated Compliance**

Kelly shared insights on how risk awareness and management have evolved within her organization since implementing FloQast. By empowering her team and enhancing accountability, they have achieved a more vigilant approach to maintaining accurate and effective controls: "Giving my team more autonomy and requiring their sign-off has significantly improved risk awareness within our organization," she said. "They know they are held accountable for ensuring that processes are carried out as documented. If there are discrepancies, it prompts a conversation, ensuring that any changes are carefully considered and important risk factors are not overlooked. This two-way accountability has enhanced our overall risk management and ensured that everyone is more vigilant about maintaining accurate and effective controls." Kelly discussed how integrating various workflows in FloQast with FloQast Compliance Management has transformed

their compliance framework. The ability to link auditing and operational tasks in <u>a single platform</u> has significantly improved their tracking and real-time visibility: "Linking various workflows in FloQast to FloQast Compliance Management has been a breakthrough for us. The integration of executing and auditing compliance in the same platform allows for a streamlined and easily trackable framework. The real-time dashboard was one of those great features you didn't know you needed until you had one; which provides a live view of our compliance status, eliminating the need to wait for quarterly updates. This seamless connection between workflows ensures that our compliance environment is always up-to-date and efficiently managed."

Despite managing SOX 404B, our budget and actuals have decreased since I began overseeing the SOX process and aligning it with the close checklists and other workflows. This continued efficiency reflects the significant impact of our improved processes."
