### How integrated technology provides a complete view of medication history.

This unique technology is embedded within electronic health record systems, pulling data from PBMs and pharmacies nationwide to give providers a complete view of a patient's medication history over the last year.



1 A provider initiates a request for medication information within a patient's EHR.

2 First, the technology finds the patient. Then, using advanced algorithms, it requests data from pharmacies and PBMs across the nation.

3 The data is neatly organized in an industry-standard file and returned to the patient's provider, making it clear and easy to read.

# See it in action.

A provider visits an elderly patient who is homebound. The patient can't remember his treatment plan due to early stages of dementia.



## *Missing information from the start*

During the visit, she asks her patient about his medications. He provides a case with mismatched, unidentified pills. It is clear more information is needed.



## *A quick search*

Normally, the provider would begin calling pharmacies and physicians to gather missing information, which could take days and put the patient at risk for an adverse event. Fortunately, the provider has access to Medication History for Reconciliation.



## *A clear and complete view*

Right away, she taps into the patient's EHR and sees an accurate and updated medication history: two prescribed pain management medications and a cardiac beta blocker.
