Items of Note about this version



Notes

Below are some items of note in WebDocs 7.2.5:

- 1. Licensing is no longer based on file counts. Instead, license counts will only be based on the number of documents and other materials stored in the system. For projects denoted as File Tracking, however, files will still count toward the overall license count.
- 2. By default, all PDF documents will be shown in the Web Viewer as a rendition. Users can disable this via the General tab under the Project Configuration area in Central Administration and select to display PDF in its native format.
- 3. QA has certified 7.2.5 to work with Windows 10. However, Microsoft's Edge web browser is not yet certified as it does not support WebDocs's drag and drop capabilities.
- 4. Expired License changes
 - A prompt will be displayed at every login starting 30 days from when the license expiration date notifying the user of the number of days left until expiration.
 - Users will not be able to log into an expired site.
- 5. QA has certified automation processes with Office 365 Integration
- 6. Enterprise Server version 7.0 is required for use with WebDocs 7.2.5. Below are a couple of enhancements made to the Enterprise Service:
 - Ability to update DLL's from the wizard automatically.
 - Ability to send emails notifying administrators of errors from the within the service.
- 7. The Aspose.dll file was updated in WebDocs 7.2.5. Due to this update, there is a strong chance that any plugin built using this file will have to be rebuilt to work in WebDocs 7.2.5.
- 8. The WebDocs logo on the login page has been updated.
- 9. Central Administration is now using icon fonts to improve the loading of the Central Administration pages.

New Features

The following new features have been added to this version:


Validations for Unsupported Character Inputs in Central Administration

When configuring your setup within Central Administration, if an invalid character is entered the system will not let you save the configuration until that character is removed.



Full Text Searching Within Search Portal


Users can use a full text search to find content on the Search Portal.






Access Documents Using a URL in the Search Portal

A document can be directly accessed within the Search Portal if they have been provided with a URL to the document. This provides a user direct access to a document without first needing to log into WebDocs.



File Details Page Multi-Level Drill-down

The File Details page shows a listing of all documents that are in a file.



Total Added to RM Storage Size Dashboard


A row has been added to the bottom of this dashboard to display the totals of each of the columns.






HTML Form Conversion to PDF in Viewers and Workflow

HTML documents can be converted when they are being exported or emailed from either viewer. The Convert stencil within the workflow process designer can be configured to convert a HTML document to a PDF during workflow processing.









Submission Form File Creation with No Documents

A submission form can now be used to only create a new file within WebDocs. A form configured with these settings will not store the form in the file after the file is created.



Web Form Paging


Page breaks can be added to web forms via the forms designer. These breaks can be used to break up a long form into different sections allowing a user to move among the different sections using buttons that are added to the form.






Web Form Print Breaks

Print breaks can be added to web forms via the forms designer. These breaks can be used to specify where a new page would start if the form was to be printed.



Update User Preferences Layout


The User Preferences area has been updated to match the layout and design of the Central Administration area.






Option List Configuration Supports Pasting from Multi-Line Source

When configuring an option list type of index field, a user can paste a list of values from a text file or Microsoft Excel Spreadsheet into the Options box found in the field edit popup.



Incomplete Status Option Added to Workflow Status Report


When running the Workflow Status Report, a user has the option to select from an "Incomplete" status. This will show the user items that are incomplete within the workflow process.






Automation Event Historical Overview Dashboard

This dashboard provides a historical look at how automation processes have been performing. Charts will provide information such as "Total Process Time by Process", "Overall Event Status" showing if the event errored or was completed, "Event Status by Process" and "Events by Server Group".



Automation Event Snapshot Dashboard

This dashboard provides information about how the automation processes are functioning in real-time. Charts will provide information such as "Overall Current Process Status", Today's Process Events" and "Today's Average Latency per Process".





What issues were resolved in this version?



Resolved Issues

The following issues were resolved in this version.

- 1. Resolved an issue where the Queue Productivity report was displaying the wrong counts in the results.
- 2. Resolved an issue where users would get a project ID error randomly when opening the File Details page.
- 3. Updated the Windows Viewer so that the File Details pane is not greyed out if a document does not exist in the file.
- 4. Resolved an issue where the Recycle Bin Cleaner and Active Directory Sync processes were not processing when a non Enterprise License was applied.
- 5. Resolved a web forms issue where calculation fields were not handling negative values properly.
- 6. Resolved an issue where PDF related documents could not be opened when using the Web Viewer.
- 7. Resolved a Top 10 charts widget issue in the workspace when two widgets were applied to the same page hovering over a pie section on one chart highlighted a section in the other.
- 8. Resolved an issue where double time stamps were being applied to PDF documents when being stamped by the workflow stamp action.
- 9. Resolved an issue when printing Netlabels on a Cloud site that would present users with an error.
- 10. Resolved a performance issue when a non-admin user would select File Now from the Add Content page after uploading documents.
- 11. Resolved an issue where uploading multi-page tiffs from the Add Content screen would mess up the display order in the viewer.
- 12. Resolved an issue where users could edit Auto-Text fields in the Web Viewer even though it would not allow them to save.
- 13. Resolved a Windows Viewer memory leak issue as users would go in and out of the viewer.
- 14. Resolved an issue when re-assigning from an assignable step, the document was not showing as completed by the original user within the Workflow Activity report.
- 15. Resolved an issue when using Chrome where users could not copy the data from the result grid and paste into the Search page.
- 16. Updated File Tracking so that the defaulted Check out to User is left blank and doesn't default to a user in the list.
- 17. Resolved an issue where the System Settings panel would not collapse after it was opened and user selected last search on top panel.
- 18. Resolved an issue in Central Administration where users could not delete e-form process steps.
- 19. Fixed multiple dashboard reporting issues.
- 20. Resolved an issue where Dashboards would not print when using Internet Explorer 11.
- 21. Resolved an issue where viewing other users assignments drop-down menu did not display all available users.

What issues were resolved in this version?



- 22. Resolved an issue with the Activity Audit log so it properly displays the documentID of the document that had an annotation applied.
- 23. Resolved an issue in Touch where e-form drop-down was not showing up properly.
- 24. Resolved an issue in workflow when using exception steps and re-routing the document it would go back to the exception step even if the issue was fixed.
- 25. Auto-index process has been fixed to properly populate project link data in a template.
- 26. Resolved an issue in Central Administration where an Access Admin had access to view project administration projects and export the projects.
- 27. With the Quality Control page users can now navigate between multiple pages of results.
- 28. Resolved an issue where My Assignments widget was not showing more than 10 results. Paging has now been added.
- 29. Resolved an issue where the Web Viewer rotate buttons would disappear when viewing a rendition.
- 30. Resolved an issue when performing a divider search from the Search page and opening the Web Viewer, the user was taken to the first page in file and not the divider that was returned in the search.
- 31. Resolved a performance issue that reduced the waiting time to open the Main Options within Central Administration.
- 32. Improved performance of viewing images in the Web Viewer by 50%.
- 33. Improved performance of loading the Web Viewer and the Web Viewer file tree by 100%.
- 34. Resolved an issue in template setup where users could not drag a zone to the bottom of an image. Autoscrolling of the zone to the bottom of the image was not working.
- 35. Resolved an issue within the Line Item panel in the Web Viewer where option list values were not displaying the correct selected value.
- 36. Fixed Central Administration so it would show hidden users in the Global E-form user selection.
- 37. Resolved an issue in template setup when using required field, a user is no longer prompted to complete required fields if they are populated.
